# 彭韻僖律師, BBS, MH, JP

彭律師為香港執業律師,同時獲准在澳洲及英格蘭威爾斯執業,亦是國際公證人、婚姻監禮人、認可調解員及中國委托公證人,現為彭耀樟律師事務所合夥人。彭律師於 2018 至 2021 年間出任香港律師會會長,為該會的首名女會長,現任該會多元共融委員會主席。彭律師現為香港家庭議會及香港報業評議會主席,同時擔任憲法和香港基本法推介聯席會議副主席、中國香港田徑總會副會長、廉政公署審查貪污舉報諮詢委員會及香港中文大學校董會成員。彭律師於 2021 至 2023 年間出任國際法律組織 LAWASIA 會長。彭律師於 2006 年獲香港特區政府頒授榮譽勳章,2010 年獲委任為太平紳士,2020 年獲頒授銅紫荊星章,並於 2023 年獲委任為第十四屆全國政協委員。彭律師於 2020 年加入本局董事會擔任副主席,自 2021 年起出任主席。

Ms Pang was the President of LAWASIA, an international legal organisation, from 2021 to 2023. She was awarded the Medal of Honour in 2006, appointed Justice of the Peace in Hong Kong in 2010 and received the Bronze Bauhinia Star in 2020.
